By signing this agreement, I agree to this following;

1. **RENTAL** – I agree to rent a Seawall Berth and/or a swing mooring and/or Dinghy Dock space for my tender from Waterfront Ltd t/as Yachting World (Vanuatu) for a period and for a prescribed periodic fee.
2. **LIABILITY** – I & all on board my Vessel, agree to fully indemnify Waterfront Ltd t/as Yachting World (Vanuatu) and its Employees and Agents against any loss or damage to any vessel, persons or property arising from this agreement.
3. **SUB-LETTING** – I agree not to sub-let this seawall berth / dinghy dock space / swing mooring to any other persons without prior written approval from Yachting World

4. **RULES & REGULATIONS** – I agree to the Rules and regulations of Yachting World that may change from time to time and may be articulated to me by Management and staff of Yachting World whilst in occupation under the terms of this agreement and include that I will ensure peaceful enjoyment to other boats and persons & not undertake any action which may be of danger to other boats and persons nor undertake any repairs to my vessel that are excessively noisy or create any type of pollution to the harbor or land.
5. **INSURANCE** – I warrant that this Vessel is under my legal control and that she holds a current insurance policy that provides for all damage that may be caused to persons or property by her or the actions of those in control of her.
6. **PAYMENT** - I warrant I have read and agree to the charges as provided to me and agree to ensure payment of monies due prior to the expiration of this agreement and upon vacation notwithstanding, if I choose to stay in excess of one week, I will settle my account on a weekly basis and based on the rate relevant to my estimated stay (subsequently adjusted to actual upon vacation)
7. **NOT LEAVE PORT VILA** – I undertake that I will not leave Port Vila in so long as this agreement is in effect unless I legally authorise another to be in control of this Vessel and that this party agrees to take such control and only if approved, and relevant documentation executed by/with Yachting World
